### The Client

Aulani, a Disney Resort & Spa, is a beachside resort hotel at the Ko Olina Resort in Kapolei, Hawaii, on the island of Oahu. Walt Disney Imagineers worked hand in hand with local artisans and cultural experts to create Aulani. Inspired by the natural wonders and rich traditions of Hawai'i, Aulani Resort is the ultimate family getaway.

### The Challenge

The Waikolohe pool is their largest resort pool. It was important to quickly fix this pool and get it operating properly.

### The Process

1] Aquatic Solutions Hawaii was commissioned to rework a 2-year, failed installation from another contractor. While demolishing, we found the pool interior had an unexpected layer of plaster which doubled the demo process. We doubled our production time, showing the demo result.  
2] The escalated time frame included working through week-ends with 12 to 14 hour work days. Our goal was to deliver the project ahead of schedule. Image shows the prepped pool stairs.  
3] Shows pool interior after the old plaster has been removed and ready for the new plaster application.  
4] Crewmen applying the final plaster treatments to the pool interior.  
5] Waikolohe Pool is completed 12 days early in October 2025.

### The Client

Brigham Young University-Hawaii is a private university located in Laie, Hawaii, United States. It is owned and operated by The Church of Jesus Christ of Latter-day Saints. BYU-Hawaii was founded in 1955 and offers programs in mathematics, liberal arts, and management.

### The Challenge

Aquatic Solutions was called to BYUH to assess a Large Commercial College pool in early April 2018. The pool was drained by BYUH maintenance staff to clean the interior. Unfortunately the pool was built with construction defects that omitted a safety device that would prevent high ground water in the area from damaging the structure. This was a 35 year old pool that was recently renovated in 2004.



The pool did not have the necessary hydraulic relief valves to alleviate the water pressure around the pool structure. The relief valves are needed to prevent high water table (which ebbs and flows), from rising and damaging the plumbing and pool shell. When the pool was drained, the high water in the area buffeted the plumbing underneath the pool and broke the lines. There was no clean gravel bed or drain system underneath the pool to assist with the water removal when draining.

We completely rebuilt the entire plumbing system and equipment while upgrading it all to include energy efficient VFD's, new redundant pumps and automated chemical systems that can be remotely operated through applications on a Smart Phone.

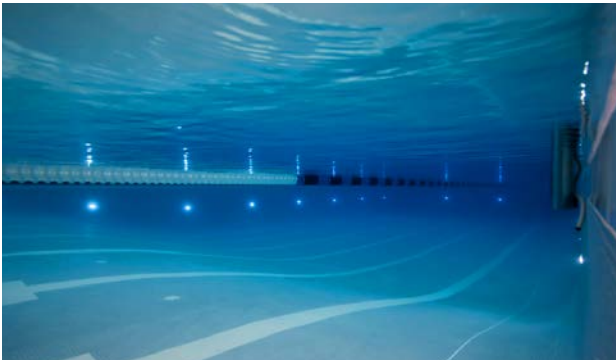

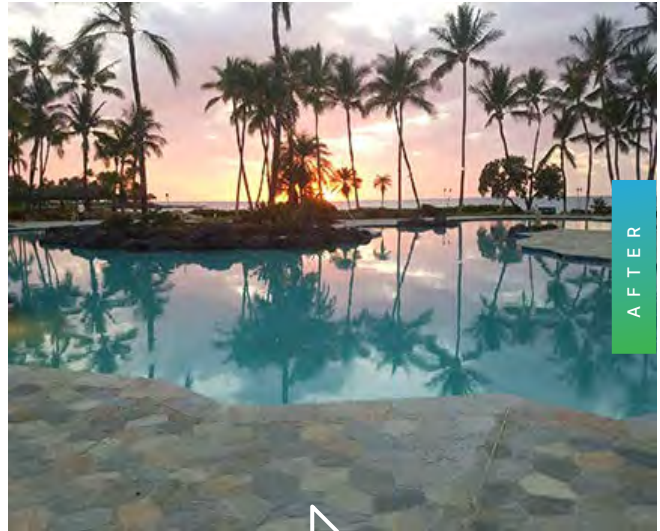

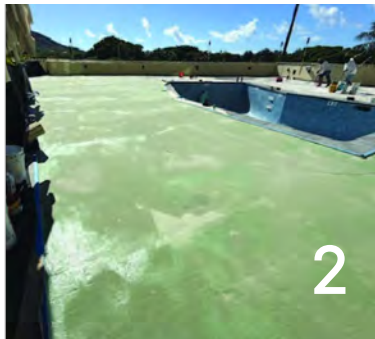

**For a hotel with high occupancy and activity, the project had a tight, challenging timeline.**

**The Client**

The historical Queen Kapiolani Hotel is a 4-star hotel in Honolulu, known for its Hawaiian history and connection to the culture and heritage of the islands.

**The Challenge**

Our challenge was to stay within the tight timeline, on budget and execute a water tight solution. The pool was in

disrepair, leaking into the offices below. The adjacent deck was also in trouble. The goal was to finish the project with a clean iconic look and a long term solution.

**The Process**

- 1] While demolishing, we found the pool interior had many layers of plaster and tile. The adjacent deck had a problem with leaking waterproof, piled layer upon layer.
- 2] With demo done and the old waterproof disposed of, we installed a new pitched mortar bed, an 80 mil

- Mapei waterproof membrane system with sand broadcast then topped it with an acrylic protection layer. The deck and pool were lap seamed with an Aquadefense Mapei interior.
- 3] To install the new tile pool interior, we used the Mapei mortar submersion rated system.
- 4] We installed a custom logo and LED lighting that faced the hotel's rooms.
- 5] Completed in 5 weeks while staying on budget and delivery timeline.

**The Client**

Yacht Harbor Towers is a premier condominium of 456 residential and 3 commercial units, located in Honolulu on Ala Moana Boulevard between Waikiki and the Ala Moana Shopping Center. All units have magnificent views of the ocean.

**The Challenge**

This pool structure was in trouble. It was

improperly repaired by a contractor 2 years earlier. Typically, pools like this are constructed within a "vault" that offer additional protection and stability.

However, due to the disrepair, the pool started leaking badly into the vault which then started leaking into the parking structure below and on to the vehicles. The repair needed to be quick, robust and thorough.

**Result**

We accomplished this project in five weeks, including flood testing and tile installation. Our client, architect and condo residents all love the results.

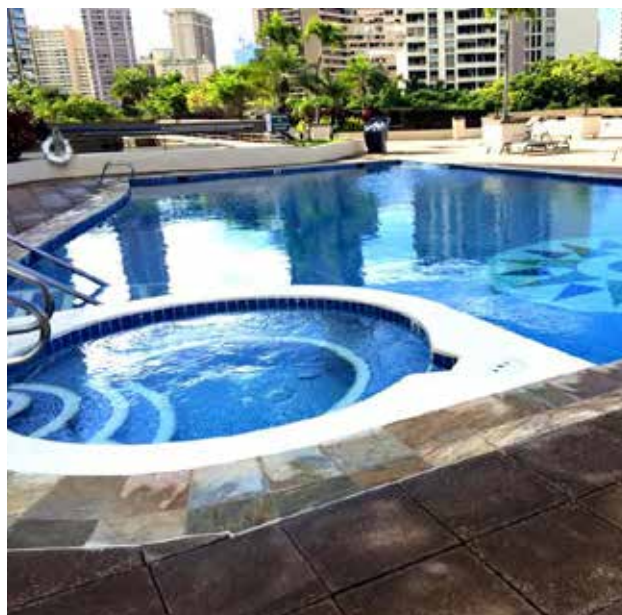
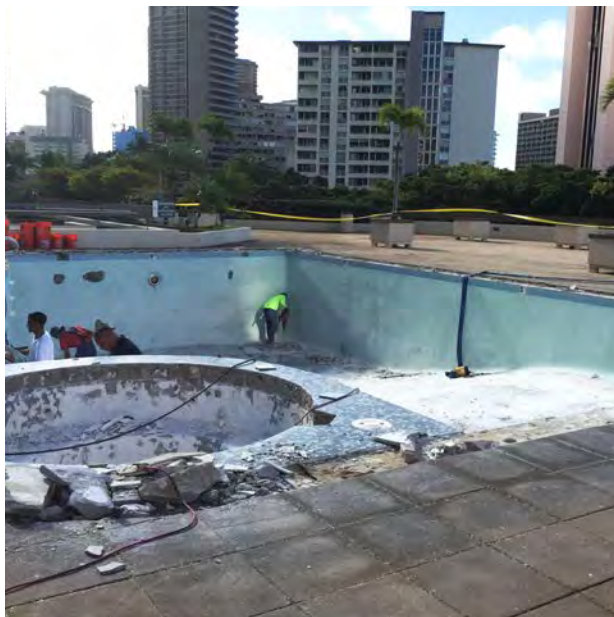

## Solution

- ✓ To accomplish this repair, we needed to strip off the previous work to reveal the original gunite structure. Once there, we needed to brown coat, waterproof, and flood test the work. At this point we had confirmed all the previous leaks had been fixed by applying epoxy collars on the plumbing penetrations. We checked this by running of the pool for 4 days to insure there was no water loss.
- ✓ We THEN proceeded to the tiling of the entire pool. The tile process added ANOTHER layer of protection via Laticrete® Platinum 254 Epoxy Adhesive and their Spectralock® grout system. Not only was the new tile set into epoxy, it carries a warranty by Laticrete for 25 years.

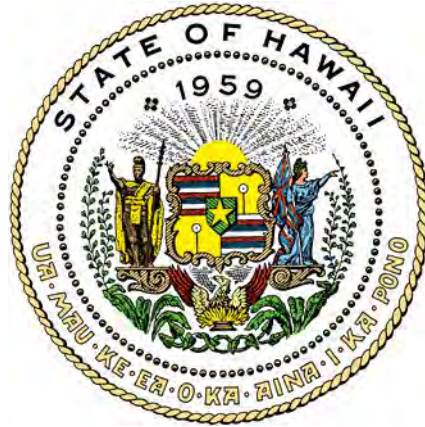
